Thank you for your request for amendment, submitted on 18 October 2016.

This is to advise that the following amendments have been approved as outlined in your application. A brief summary of the changes is included below:

Changes to Recruitment

- Summer scholars, under the supervision of the reception staff, will hand out the iPad to patients previously identified by staff in practices identified as 'slow recruiters.' They will use the script previously approved by Monash HREC for use by receptionists.
- Summer scholars will observe patient interviews in Week 1, then conduct the patient interviews in Week 2 under supervision of the Project Manager and Project Coordinators.
