Who is doing the Research?

The project is being conducted by Simren Bart, a clinical psychology student, and Dr Trevor Mazzucchelli, Senior Lecturer at Curtin University.

What will I have to do?

If you agree to take part in this study, you will be asked to log onto a website where you will be randomly assigned to one of two writing tasks that will encourage you to write about a personal problem that you have experienced in the past. Before the writing tasks, after, and one week later, you will be asked to complete several questionnaires relating to your feelings about the personal problem and what you have written. Both online surveys and writing task will take about 60 minutes in total to complete. You will be asked to provide your email address so we can invite you to participate in the second part of this study.

Do I have to take part?
