- The Coordinating Principal Investigator will notify the RHC QLD HREC if the project is discontinued at a participating site before the expected completion date, with reasons provided.
- Any extension to the initial approval period is to be requested in a writing to the RHC QLD HREC together with the inclusion of a progress report and any associated required documentation.
- The Coordinating Principal Investigator will notify the RHC QLD HREC of his or her inability to continue as Coordinating Principal Investigator including the name of and contact information for a replacement.
- The Coordinating Principal Investigator will notify the RHC QLD HREC if the project does not commence within six months of approval.

Your approval is initially for four years from date of approval; after this period, you may be asked to apply for an extension or re-apply. You are also required to notify the Committee promptly of any changes in your contact details.

A copy of this ethical approval letter should be presented when required as official confirmation of the approval of the RHC QLD HREC.
